- **Non-flight** – DHA Form 237 (OCT 2024), follow Tripler website application procedures
 - **ICL OK**

▪ **NAVY/MARINE:**

- **Flight Status – LASIK preferred, Flight Surgeon approval**
 - **Pilot (Class I): NO ICL**, US Navy surgeon only
 - **NFO/Aircrew (Class II): ICL OK**, LASIK preferred
 - **Air Traffic Control/ UAV (Class III,IV): ICL OK**, LASIK preferred
 - LASIK: -11.50 → +6.00 SE; Cyl <6.00; PRK no limit
- **Dive/Spec Ops/EOD/Marine Recon:**
 - **Qualified:** 1 month no special duty
 - **Applicant:** 3 month waiting period after CRS
- **Submarine Duty:**
 - **Qualified:** must be on shore duty/shipyard for at least 3 months with 30 days remaining AFTER surgery before sub ops
 - **Applicant:** 3 month waiting period after CRS
